## **2. NGO FOUNDATION PROCESS**

Seven foundation members could establish a NGO in Nepal.

Every organization has its own constitution with stipulations in its objectives, membership, member meeting, member's rights, functions and duties, etc.

The organization is subjected to Society Registration Act, 2034 and is registered at the District Admin Office, District Local Development Office, Social Welfare Society and Tax Office.

A mandated lawyer arranged the foundation process, which lasted approximately one month.

Our in Nepali written constitution is already translated. For every interested donor we would like to provide an insight into the English version.
